INDICATIONS

Turbovite® VITALITY is a supplement that contains fructose, vitamin C, minerals as well as *Panax ginseng* and *Ginkgo biloba*, two ancient herbal remedies, traditionally used for improving memory, alertness and concentration. B-vitamins are generally associated with metabolism [B-vitamins help the body convert food (carbohydrates) into fuel (glucose), which the body uses to produce energy] and the maintenance of healthy nerve functions as well as overall well-being. The combination of active ingredients can assist the body to cope with the physical and mental challenges of daily life. Efficacy of support may vary between users. Not suitable for people with diabetes.

CONTRAINDICATIONS

Do not use if known hypersensitivity or allergy exists towards any of the ingredients. If in doubt, consult your medical practitioner. Consult your medical practitioner if you have any of the following conditions; high blood pressure, recent heart attack, abnormal heart rhythm, ulcer, inflamed colon, severe liver disease, seizures, chronic trouble sleeping, moderate to severe kidney impairment, blood clotting disorders or change in blood platelet function.

Use with caution in people with diabetes or hypertension, as *Panax ginseng* can have an effect on blood sugar levels and blood pressure. Do not exceed the recommended daily dosage. Side effects may include, but are not limited to; headache, dizziness, restlessness, nausea, vomiting, diarrhoea and constipation.
